Human Settlements Department has been granted permission by Gauteng Department of Human Settlements to use the land as decant area for re-blocking. The environmental screening has been conducted and the results are in support for re-blocking. Re-blocking has started.

The request for timeframe in regards to John Dube Mega Project.

Time lines on the project delivery of the 86 RDP Walk-ups are currently being implemented for completion at the end of June 2022 as the phase one of the delivery on 608 planned for the two financial years depending on availability of Human Settlements Development Grant funding from Gauteng Department of Human Settlements to the Developer.

1996/99 waiting list applicants will be prioritised as per newly approved housing allocation policy.
